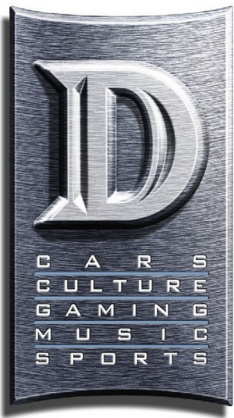

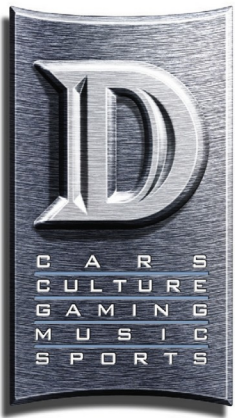
## About Detroit Metro Convention & Visitor Bureau
